# Inaugural Meeting of Consett Area Neighbourhood Forum 3pm, 14 January 2024 The Steel Club, Consett

# 1. Adoption of the Constitution

The meeting was updated on two late amendments to the previously circulated draft constitution, requested by Durham County Council. i.e.:

- The removal of text referring to a potential future subscription for membership
- The addition of a paragraph concerning the aspiration to hold in person meetings in different locations across the Neighbourhood Area

Christine also explained the basis for the geographical area chosen for the Neighbourhood Area.

There was then a vote to formally adopt the constitution for Consett Area Neighbourhood Forum. This was passed unanimously.

# 2. Appointment of officers and members of the Management Committee

The following members introduced themselves and put themselves forward for the positions of officers, as follows:

- Christine Thomas Chair
- Mike Shiels Secretary
- Anne Louise Grant Treasurer
- Lucy Reed Data Protection Officer

Members present were offered the opportunity to stand for any of the above positions. There being no further candidates, each position was put to a vote of the Forum in turn and all of the above were adopted unanimously.

The following members were then proposed to take up the 6 remaining positions on the Management Committee:

- John Million
- Kelli Turner
- Mark Russell
- Maureen Clyne (not present)
- Niamh McDonald
- Richard Lumley

Members present were offered the opportunity to stand for any of the above positions. There being no further candidates, this list was put to a vote of the Forum and adopted unanimously.

For information, short supporting statements by the Management Committee members are included in Appendix 1.

## 3. Progress Update

Christine provided the following updates:

- The Forum has been allocated initial Restricted Funding of £9,858. This can only be used for specific purposes that have been previously stated
- Our advisors, Locality, proposed a list of 10 local planning companies to work with us, but none were do so due to conflicts of interest. Instead, Christine identified Jo-Anne Garrick BSc (Hons) MTP(UC) MRTPI - a local independent planner who has agreed to work with us.
   We have secured 14 days of her work at a cost of £7,700
- We have also contracted for an initial website design using Elm Marketing (a Forum member) at a total cost of £914.
- The remainder of the grant is to be used for admin costs and liability insurance

In addition to this, we are funded for technical support from Locality, to get professional advice where needed on specialist subjects.

### 4. Forum website

Currently we have a basic framework – this will be put live to the public shortly. Members are invited to put forward any ideas to improve the contents.

We intend to include a form through which local businesses, charities and other organisations within the Neighbourhood Area can register to be listed on the Forum website. This is to support commerce and community activities in the area.

# 5. Neighbourhood Plan

The meeting discussed the process by which a neighbourhood plan will be created. All members are welcome to be involved in any part of this process, e.g., by participation in sub committees.

In an open discussion, members proposed the following as potential topics to prioritise:

- Accessibility to services for elderly and disabled
- Parking, including disabled provision
- Housing for different demographics: families, elderly, disabled
- School provision, especially local primary school for housing developments
- Provision of bus stops
- Provision of community facilities (with accessibility, wifi, parking, etc)
- Traffic calming, use of 20mph zones
- Supporting new businesses to move to Consett area
- Extra care facilities with on-site carers, service, etc.
- Quality of road signage such as street names not clear and readable
- Opportunities for young people to encourage them to develop and grow their careers in the local area

It was noted that we should draw on previous work, surveys, etc. rather than re-inventing. We should also look at examples of good practice from neighbouring areas, such as Gateshead, Sunderland, etc.

Alan Shield has secured agreement that CANF can meet with local planners, and he is happy to facilitate this as soon as we are ready.

## 6. Charitable incorporated Organisation

Christine explained the concept of a Charitable incorporated Organisation (CIO). This is a mechanism that will allow us to receive charitable funds that can be deployed in this area. It was not possible to

proceed with the establishment of a CIO until the Form was formally established (i.e., today). The Management Committee will now proceed to establish the CIO.

# 7. Any Other Business

The following items were submitted prior to the meeting for consideration:

# Objections to the Forum

Michael Hogan wanted to highlight some of the objections raised in the consultation on the establishment of the Forum. It was noted that we have tried to address these points within our constitution, which makes it clear that the Forum is open and non-partisan.

# Local Signage

Jean Fraser raised concerns about the quality of street name signage. The lettering is often worn or faded, so that it is difficult to read, especially for the visually impaired.

The meeting closed at 5pm.

# Appendix 1: Members of the Management Committee

#### **Christine Thomas**
